Solihull Safeguarding Children Partnership Re-brand!

As part of our improvement journey, it was decided that now would be a good time to re-brand the Partnership and combine our new visions and values with a new logo and look. Solihull Right Help, Right Time, Right Response Launch

Throughout December Solihull Safeguarding Children Partnership are holding three events, which are now fully booked with a good representation from partner agencies, to raise awareness of the latest developments by Solihull Safeguarding Children Partnership. These include:

- Voice of the Child Practice Standards

The events are aimed at Practitioners, managers and leaders in all agencies who are directly responsible for providing safeguarding interventions, including early help and child protection interventions for children and their families. Leads who attend have been asked to share and embed this information in their organisation's practice; if you are not attending an event, please take the opportunity to follow the links and read the information above to share and use it within your safeguarding work.

Inspections Updates

Appointment of the Children's Commissioner - the Secretary of State has appointed Sir Alan Wood as Commissioner for Children's Services in Solihull. His role is set out in the Statutory Direction located at: https://www.gov.uk/government/publications/direction-issued-to-solihull-metropolitan-borough-council Sir Alan Wood commenced in his role on 1 November 2022 and will be publishing his report in January 2023.

Joint Learning from DHRs, SARs and CSPRs – Quick Guides

West Midlands Regional Procedures Updates Bullying

Bullying is defined as 'behaviour by an individual or group, usually repeated over time, which intentionally hurts another individual or group either physically or emotionally'. A child who bullies is defined as 'a person who habitually seeks to harm or intimidate those whom they perceive as vulnerable' (The Diana Award).

This procedure covers several types of bullying from hate crime to sexualised bullying and harassment.

The West Midlands Regional Procedures Group updated this in October 2022 so please could you ensure you familiarise yourselves with this updated version here.

West Midlands Regional Section 11 and Care Act Compliance Audit Tool

In the New Year, the Partnership will be launching a new Regional Audit Tool which covers both the Section 11 Audit and Care Act Compliance requirements. This audit will launch at the same time across the Wider West Midlands in the hope it will minimise the impact on partner agencies who work cross-border and who would previously have received multiple requests for audits across the year. We had hoped this tool would be launched in the Autumn however there are some further tweaks to develop the tool which will be beneficial for both partners and partnerships. For those who will be asked to complete the tool, further communications will be sent to you in due course.


VRU Training on the Impact of Gangs on Girls and Young Women

Birmingham City Council in partnership with Barnardo's Training and Consultancy Service is delivering a FREE Introductory awareness raising, half day session to provide multi-agency practitioners, community representatives and carers with the skills, knowledge and confidence to recognise and initially respond to girls and young women at risk from gangs, county lines and criminal exploitation. This training will be delivered through a solution focused approach.

The training will be delivered by subject expert, **Mark Pearson.** Mark has extensive experience in policing and multi-agency working, including having held the role of police lead in an award winning co-located multi-agency team whose primary focus was on safeguarding both young women and young men and families affected by gangs and criminal exploitation.

SSCP Quarterly Learning Briefings

From early January the Solihull Safeguarding Children Partnership will be circulating quarterly learning briefings to strategic leads in partner agencies with a request from the Chair of the Learning and Development Group that they review the key messages and consider what action needs to be taken to embed the learning across their organisation. Each briefing will include a summary of the most recent learning from multi-agency audits and reviews of serious incidents in Solihull, as well as key messages from national learning. Strategic leads will be asked to provide written assurance on the action they have taken to embed the learning across their workforce. The quarterly learning briefings will also be published on the SSCP website and referenced in future newsletters.
