## **CROSS BOUNDARY ISSUES**

## 1. What is Meant by 'Cross Boundary Issues'?

A border is a dividing line, marking the boundary of an area. Due to differences in administration, organisations will have geographical and/or service boundaries. For example as a local authority our responsibility is Solihull borough. In contrast West Midlands Police has a regional boundary.

Many people don't think about the local boundaries they cross within their daily activity, but are aware when they cross the boundary of a country, as this often requires them to produce their passport to exit or enter.

Solihull is a Metropolitan Borough Council area of the West Midlands, situated in the middle of two of the region's larger city councils; Birmingham & Coventry. It is also bordered by Staffordshire, Worcestershire & Warwickshire. In addition there is an international border with Birmingham Airport.

## 2. Key Messages

- Be aware that other organisations may have or are engaged with an individual or family of concern. This may be because they accessed their services from a location outside Solihull, or because they have recently moved into the borough.
- When someone in need moves between Local Authority areas it's essential the transferring authority notify the receiving authority of the concerns and the nature of their involvement and plans.
- All involved agencies should ensure that they give timely and appropriately comprehensive information to their counterparts in other areas.
- Consideration should always be given to the resource being provided by the community a person is living in. For those already socially excluded, moving can worsen the effects of their exclusion and increase their vulnerability.
- Moving people away from a local area is not an effective long term solution to protect them from criminal gangs

Risks may increase by complicated cross boundary arrangements and it may be dangerous if organisations and professionals don't understand their responsibilities
Swift action is needed when safeguarding people who've been trafficked into the UK
